# 1. APPOINTMENT AS SCRUTINIZERS:

We, M/s. RAAM & Associates LLP, Practicing Company Secretaries were appointed as the Scrutinizers by the Board of Directors of the Company at its meeting held on February 12, 2025 for conducting the Postal Ballot / e-voting process in a fair and transparent manner and in accordance with the Companies act 2013 and Rules made there under.

Our responsibility as a Scrutinizer for remote e-voting process is restricted to make a Scrutinizer's Report of the votes casted "in favour" or "against" the resolution stated in the Notice of the Postal Ballot dated February 20, 2025 based on the reports generated from the remote e-voting system provided by MUFG Intime India Private Limited ("MIIPL") (Formerly Link Intime India Private Limited), the authorized agency to provide remote e-voting facilities and engaged by the Company and documents furnished to us electronically by the Company and/or MUFG Intime India Private Limited ("MIIPL") (Formerly Link Intime India Private Limited) for our verification.

## 2. MANAGEMENT'S RESPONSIBILITY:

The Management of the Company is responsible to ensure the compliance with the requirements of –

(i) the Companies Act, 2013 and the Rules framed thereunder:



- (ii) the Circulars and Notifications issued by the Ministry of Corporate Affairs ('MCA') from time-to-time; and
- (iii) The SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 ('LODR') relating to remote e-voting process on the resolution contained in the Postal Ballot Notice. The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems.

### 3. <u>DISPATCH OF NOTICE CONVENING THE POSTAL BALLOT MEETING AND ADVERTISEMENTS:</u>

- i). Notice were published in Free Press Journal (English) dated: February 21, 2025 and Nav Shakti (Marathi) dated: February 21, 2025 respectively specifying availability of the notice on Company's website and website of the Stock Exchanges, manner of registration of email Ids by the members (both physical and demat) who are yet to register their email ids with Company, manner of voting through remote e-voting and other requisite information and contact details of RTA MUFG Intime India Private Limited ("MIIPL") (Formerly Link Intime India Private Limited).
  - ii). The Company hosted the **notice** of Postal Ballot on its website and **website** of the agency providing the platform for remote e-voting and also intimated the same to the Stock Exchanges (i.e. BSE Limited and the National Stock Exchange of India Limited) on **February 20, 2025**.
- iii). On the basis of the Register of Members and the List of Beneficiary Owners made available by the depositories viz., National Securities Depository Limited ('NSDL') and Central Depository Services (India) Limited ('CDSL'), MUFG Intime India Private Limited ("MIIPL") (Formerly Link Intime India Private Limited) ('RTA') the Company completed dispatch of the Notice of the Postal Ballot as under:
  - On February 20, 2025 by e-mail to 30637 members who had registered their email IDs with the Company / Depositories.



## 4. <u>CUT-OFF DATE:</u>

The Voting rights were reckoned as on **Friday, February 14, 2025**, being the Cut-off date for the purpose of deciding the entitlements of members at the remote e-voting

### 5. REMOTE E-VOTING:

- (i) The Company had appointed MUFG Intime India Private Limited as the agency for providing the remote e-Voting platform.
- (ii) The Remote e-Voting platform was open from Friday, February 21, 2025 (09:00 a.m.) to Saturday, March 22, 2025 (5:00 p.m.). Remote E-voting was blocked by MIIPL thereafter and was not allowed to vote beyond the said time and date.
- (iii) The votes cast during the remote e-voting were unblocked on Saturday, March 22, 2025 after the conclusion of the e-voting time period.
- (iv) Thereafter, the details containing, inter alia, the list of Equity Shareholders who voted 'in favour' or 'against' the resolutions that was put to vote, based on the report generated by MUFG Intime India Private Limited and relied upon by us, data regarding the remote e-voting was scrutinized on test check basis.

# 6. **COUNTING PROCESS:**

- i). On completion of the remoting e-voting period, we downloaded the final report/results on remote e-Voting from <a href="https://instavote.linkintime.co.in/">https://instavote.linkintime.co.in/</a>, e-Voting platform provided by MUFG Intime India Private Limited ("MIIPL") (Formerly Link Intime India Private Limited).
  - ii). The e-votes were reconciled with the records maintained by the Company and MUFG Intime India Private Limited ("MIIPL") (Formerly Link Intime India Private Limited), RTA with respect to the authorizations lodged with the Company.



# 7. RESULTS:

- We observed that 155 members for resolution 1 and 154 members for resolution 2 and 3
  respectively had casted their votes through remoting e-voting out of which there were no
  invalid votes.
- ii). We submit herewith the Report with respect to the agenda item as set out in Postal Ballot Notice, is annexed herewith and marked as Annexure I
- iii). Based on the aforesaid result, we report that the Resolution as contained in Item No. 1, 2 and3 of the Notice have been passed with requisite majority.
- iv). All electronic data and relevant records of voting are being handed over to the Company Secretary for safe keeping.
